FIVE DAYS IN MOSCOW

The Women's International Democratic Federation was founded in Paris in 1945 by a ~~Congress~~^{group} of nine hundred women from ~~the~~ 41 ~~countries~~^{of the world} who met there during one momentous week to find ways and means of joining their human strength, and together with the eighty-one million women they represent, moving forward as partners and neighbors into the adventures of world democracy.

There were women from China, from England, from Belgium, the Soviet Union, India, Greece, Argentina, France, Yugoslavia, Italy, Bulgaria, Spain, the United States, Finland, Australia and Morocco... from every ~~shore~~^{and city} in the world where women ~~were~~ ^{were} eager ^{and able} to share in the work of securing a peaceful and civilized way of life for themselves and the people ~~of~~ their country, free from the atavistic and wicked ~~staple~~^{staple} of war.

The majority of ~~them~~^{of women} had suffered the immediate and brutal impact of the most violent war in human history during the invasion and occupation of their country by the fascist enemy, and brought to the meetings of the Congress such vivid reports of this tragic experience that those of us who had been spared it, like the delegates from the United States, could only ~~wonder~~^{wonder} at the endurance of ~~the~~^{the} spirit that had survived it - ~~wonder~~^{wonder} and admire.
